





Length of Ph.D Thesis:

The length of the thesis can ordinarily be between 300 to 400 typed pages, including appendix bibliography (thesis – size) etc. However, those are only indicative and not binding. Ph. D Thesis based on statistical and experimental data can be of smaller size. The guiding teacher will be the final judge.

2.6 The research center can allot the guide to the candidates as per the clause no. 11.2 of the VCD after the selection through properly constituted interview committee.

2.7 The candidates can submit their research proposal to the Centers and same shall be forwarded by the research Centers along with the prescribed fees to the Thesis Section of the University within 21 days from the date of admission.

2.8 The candidates can submit their registration form to the centre after the approval of proposal by RRC and same shall be forwarded to the Thesis Section along with the registration fees and tuition fees share immediately but not later than 20 days from the admission.
